Dear Mr. Cole,

Charney, "The Bouverie Pusey" School.

Thank you for your letter of the 13th July, 1950, with regard to the charges to be made for the letting of school premises. A booklet is being prepared on letting charges, but in the meantime I am enclosing a copy of the letter which was sent to Miss Benson which gives full information on this matter and from which you will note that the Authority has the right to let the premises from Mondays to Fridays (both days inclusive), and the School Managers have the right to let the premises on Saturdays and Sundays.

My Committee would, I am sure, be prepared to allow you the use of the school premises for Church meetings on payment of charges similar to those made for Parish Council meetings and these are referred to im paragraph (1) (ii) of the attached letter.

Fuel and light is charged for at the lowest possible figure and to reduce these amounts any further would mean that the Authority would have to suffer a loss. The rates payable to the cleaner are, of course, laid down by the Joint Industrial Council, and payments below this scale would undoubtedly cause trouble with the Trade Union.
